- 2.1 Hydrostatic Test as per ISO15500-4 clause 6.2;
- 2.2 Leakage Test as per ISO15500-4 clause 6.3;
- 2.3 Excess Torque Resistance Test as per ISO15500-2 clause 7;
- 2.4 Bending Moment Test ISO15500-2 clause 8;
- 2.5 Continued Operation Test as per ISO15500-4 clause 6.4.

3. Conclusion

The tested valves have passed the hydraulic test/leakage test/Excess torque resistance test/Bending moment test/continued operation test as per ISO15500-2:2016 & ISO15500-4:2012+A1:2016.
